The Trunk Road (Hook Rise, Kingston upon Thames) (Restriction of Traffic) Order 1972

The Secretary of State for the Environment hereby gives notice that on 6th March 1972 he made the above-named Order the effect of which is:

- (a) to prohibit motor vehicles other than mopeds from proceeding in the cycle track on the north-east side of Hook Rise adjacent to the south-western boundary of Bidmead Court, Kent Way; and
- (b) to impose one-way working from north-west to south-east in the service road on the north-east side of Hook Rise between the south-eastern end of the cycle track referred to at (a) above and Fullers Way (north), i.e. from the road serving Nos. 322 to 342 Hook Rise North.

To give effect to the proposed prohibition of motor traffic (other than mopeds) from the cycle track the Secretary of State intends, at the coming into operation of the Order, to exercise his powers under section 70 of the Road Traffic Regulation Act 1967 (as amended) to authorise the placing of bollards or other similar obstructions at each end of the or other similar obstructions at each end of the cycle track.

Exemptions are provided in the Order to enable a motor vehicle to proceed in the cycle track:

- (a) if it is being used in connection with any (a) if it is being used in connection with any building operation, demolition or excavation in Hook Rise, the removal of any obstruction to traffic, the maintenance, improvement, reconstruction, cleansing or lighting of Hook Rise or the laying, erection, alteration or repair of the services therein; or
 (b) if it is being used for fire brigade, police or ambulance purpose
- ambulance purposes.

The Trunk Road (Lowestoft Inner Harbour Bridge) (Control of Pedestrians) Order 1972

The Secretary of State for the Environment has made an Order under section 1 of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968. The effect of the Order is that:

- (a) no pedestrian, unless he is propelling a vehicle (other than a perambulator, push-chair or invalid chair) or is leading an animal (other than a dog) shall proceed in the carriageway of that length of the A.12 Trunk Road carried by the bridge and the approaches thereto the bridge, and the approaches thereto, over the channel connecting the Inner Harbour and the Outer Harbour in the Borough of Lowestoft ; and
- (b) no person shall proceed or wait on the bridge during the period when the flashing lights at each end of the bridge are operating.

Exceptions have been provided in the Order to enable a pedestrian to proceed in the carriageway of the trunk road if he is engaged on the maintenance of the road or any of the services therein, the removal of any obstruction to traffic or it is necessary for him to do so to prevent an accident or to give help required as a result of an accident or emergency.
