

- (c) to prevent vehicles from making a right-hand turn from Preston Road into North Road, Preston; and
- (d) to prevent vehicles proceeding in the length of dual carriageway in Preston Road from 135 feet south of South Road northwards for 730 feet in a direction other than so as to keep the central island on the right-hand or off-side of the vehicle.

Copies of the Orders which will come into operation on 22nd March 1972 and maps showing the roads affected may be inspected at the Enquiry Office at the Town Hall, Brighton, between 9 a.m. and 5 p.m. on Mondays to Fridays and between 9 a.m. and noon on Saturdays.

If you wish to question the validity of the Orders or of any provision contained in them on the ground that they are not within the powers conferred by the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968, or on the ground that any requirement of that Act or of any regulation made under it, has not been complied with in relation to the Orders, you may, within six weeks from the 8th March 1972, apply to the High Court for this purpose.

BRIGHTON COUNTY BOROUGH COUNCIL

The Brighton Corporation (Eastern Road/Rock Grove/Rock Street) (Prohibition of Waiting) Order, 1972.

Notice is hereby given that on the 8th March 1972, the Brighton County Borough Council made an Order under sections 1 (1), (2) and (3) of the Road Traffic Regulation Act, 1967, as amended by Part IX of the Transport Act, 1968, the effect of which is to prohibit waiting in the parts of roads set out in the Schedule to this notice.

The Order which will come into operation on the 22nd March 1972, will contain the usual provisions permitting vehicles to wait for persons to board or alight or goods to be loaded or unloaded or, if it is a Post Office vehicle, for delivering or collecting postal packets; to enable the vehicle to be used in pursuance of statutory powers or duties or in connection with any building operation or demolition, the removal of any obstruction to traffic or the maintenance of the roads or the services therein, or in connection with bill posting, window cleaning or chimney sweeping.

A copy of the Order and a map showing the roads affected may be inspected at the Enquiry Office at the Town Hall, Brighton, between the hours of 9 a.m. and 5 p.m. on Mondays to Fridays and between 9 a.m. and noon on Saturdays.

The Brighton Corporation (Various Roads) (Prohibition and Restriction of Waiting) Order 1972

Notice is hereby given that on the 8th March 1972, the Brighton County Borough Council made an Order under sections 1 (1), (2) and (3) and 84D (1) of the Road Traffic Regulation Act, 1967, as amended by

Part IX of the Transport Act, 1968, the effect of which is:

- (a) to prohibit waiting at all times and to prohibit loading and unloading between 8 a.m. and 9 a.m. and between 5 p.m. and 6 p.m. in the parts of roads set out in Schedule 1 to this notice;
- (b) to prohibit waiting at all times in the parts of roads set out in Schedule 2 to this notice;
- (c) to revoke and re-enact the existing provisions in The Brighton Corporation (Various Roads) (No Waiting and Restricted Waiting) Order 1968 and The Brighton Corporation (Beaconsfield Road and Preston Road) (No Waiting) Order 1969 so far as they relate to Preston Road; and
- (d) to revoke and re-enact the existing provisions of The Brighton Corporation (South Road) (No Waiting) Order 1963 as amended except so far as it relates to the south side of South Road for a distance of 100 feet from Preston Road.

The Order will come into operation on the 22nd March 1972, will contain the usual provisions permitting vehicles to wait for persons to board or alight or goods to be loaded or unloaded or, if it is a Post Office vehicle, for delivering or collecting postal packets; to enable the vehicle to be used in pursuance of statutory powers or duties or in connection with any building operation or demolition, the removal of any obstruction to traffic or the maintenance of the roads or the services therein or in connection with bill posting, window cleaning or chimney sweeping. Loading and unloading will be prohibited in the parts of roads described in Schedule 1 to this notice between 8 a.m. and 9 a.m. and between 5 p.m. and 6 p.m.

Preston Drive—south side, from Preston Road eastwards for 250 feet.

Preston Drive—north side, from Preston Road eastwards for 180 feet.

Preston Road—west side, from 175 feet south of South Road, to 90 feet north of North Road.

Preston Road—east side, from 220 feet north of Preston Drive to the north side of the northern entrance to Preston Park.

South Road—south side, from Preston Road, westwards for 100 feet.

South Road—north side, from Preston Road, westwards for 175 feet.

SCHEDULE 2

Parts of road where waiting is prohibited at all times

Lovers Walk—east side.

Lovers Walk—west side, from Preston Road for 98 feet.

Preston Road—south-west side, from 520 feet north-west of Stanford Avenue, to 175 feet south of South Road.

Preston Road—north-east side, from 520 feet north-west of Stanford Avenue, to the north side of the northern entrance to Preston Park. (361)
