ROAD TRAFFIC

The Trunk Road (Stony Stratford) (Prohibition of Right-hand Turns) Order 1972

Made 13th March 1972
 Coming into Operation 18th March 1972

The Secretary of State for the Environment in exercise of his powers under section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967 (1967 c. 76) as amended by Part IX of the Transport Act 1968 (1968 c. 73) and of all other enabling powers hereby makes the following Order:

1. This Order may be cited as the Trunk Road (Stony Stratford) (Prohibition of Right-Hand Turns)
