#### THE MONEYLENDERS ACTS, 1900 TO 1927

Whereas on the 14th July 1971, pursuant to the powers conferred by the above-mentioned Acts the Secretary of State made an Order exempting Standard Guarantee Limited whose address is 97 Mortimer Street, London, W1N 8BP, from the above Acts.

And Whereas the Department of Trade and Industry in pursuance of section 123 (1) of the Companies Act 1967, have given a Certificate dated 22nd March 1972, that they are satisfied that Standard Guarantee Company Limited can properly be treated for the purposes of the Moneylenders Acts 1900 to 1927 as being a person bona fide carrying on the business of banking.

Now Therefore, the Secretary of State, in exercise of his powers under Regulation 10 of the Moneylenders (Body Corporate) Regulations 1927, by this Order revokes the Order exempting Standard Guarantee Company Limited from the above-mentioned Acts from the date hereof.
