DEPARTMENT OF THE ENVIRONMENT

TOWN AND COUNTRY PLANNING ACT, 1971

The Secretary of State for the Environment hereby gives notice that he proposes to make an Order under section 209 of the above Act to authorise the diversion of Back Street between Bowes Street and High Street, Blyth to enable development consisting of an extension of a petrol filling station to be carried out by Texaco Limited.

The proposed Order will require that the new length of highway which Texaco Limited has agreed to provide as the diversion is to be a highway maintainable at the public expense, for which the highway authority is to be the Council of the Borough of Blyth.
