On 10th January 1972, D.P.C. Kong was employed, in civilian clothes, on anti-crime duties in Kowloon. In the course of his duty he entered the front door of the National Banque de Paris which, unknown to him, was being robbed by three persons, two of whom were armed with knives, the third with a pistol. a pistol.

As the D.P.C. entered he was immediately threatened by the robber armed with a 45 calibre pistol. The officer was then forced to face a wall with his hands above his head. In all, thirteen employees or customers were being held in a similar

employees or customers were being held in a similar stance in various parts of the bank.

By moving his head slightly, the officer was able to see that the armed robber had moved some seven or eight feet away. Since no other person was in direct line of fire, D.P.C. Kong discreetly but quickly lowered his arms, and with his left hand unfastened his revolver holster, which was secured to his trouser belt and hidden by his jacket, and with his right hand drew his nistol.

On seeing the D.P.C.'s action, the robber fired his gun, just as the officer spun round. The shot missed, and the officer fired two shots in reply, one of which struck the robber on the left arm. Further shots were exchanged by the pair, and although the D.P.C. was struck by a bullet in the right leg, the three robbers fled from the bank, taking only \$16,200 with them, which they had seized just before the shooting action headen. began.
