## DEPARTMENT OF THE ENVIRONMENT

### TOWN AND COUNTRY PLANNING ACT, 1971

The Secretary of State for the Environment hereby gives notice that he has made an Order under section 209 of the above Act entitled "The Stopping-Up of Highways (City and County Borough of Liverpool) (No. 4) Order 1972" authorising the stopping-up of a length of Hughes Street and adjoining and adjacent passageways at Liverpool.

Copies of the Order may be obtained, free of charge, on application to the Department of the Environment at the office of the Regional Controller (Roads and Transportation) North West Region, Sunley Building, Piccadilly Plaza, Manchester, M1 4BE (quoting DNW 80835/1/08) and may be inspected at all reasonable hours at the Municipal Buildings, Dale Street, Liverpool.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the

powers of the above Act or that any requirement of that Act or of any regulation made thereunder has not been complied with in relation to the Order, may, within 6 weeks of the 25th April 1972, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

### ROAD TRAFFIC REGULATION ACT, 1967

*The Trunk Road (Kennford, Splatford Cross, Trehill Lodge) (Prohibition of Driving) Order, 1972*

The Secretary of State for the Environment has made 3 Orders under section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968. The effect of the Orders is to close the following gaps in the central reservation of the London—Penzance Trunk Road (A.38), in the Rural District of St. Thomas, Devon:

- (a) Opposite the junction with the classified road (No. 20) to Kennford;
- (b) Opposite the classified road (Devon County Council Route No. 433) leading to Kenn and Splatford; and
- (c) Opposite the classified road (Devon County Council Route No. 1774) leading to Trehill Lodge and Bickham House.

The closures form part of a major improvement scheme which includes a grade separated junction, i.e. a flyover.

Any person who desires to question the validity of, or of any provision contained in the Orders, on the ground that they are not within the powers with respect to the Orders conferred by the above Act, or on the ground that any requirement of, or of any instrument made under, any provision of that Act has not been complied with in relation to the Orders, may within 6 weeks of 20th April 1972, apply to the High Court for the suspension or quashing of the Orders or of any provision contained therein.

### ROAD TRAFFIC REGULATION ACT, 1967

*The Trunk Road (Prohibition of Waiting) (Clearways)*

Notice is hereby given that the Secretary of State for the Environment proposes to make an Order under section 1 (1), (2) and (3) and (6) of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968, the effect of which will be:

1. To prohibit waiting on any of those main carriageways forming part of the London—Penzance Trunk Road (A.38) which are specified in the Schedule hereto; and

2. To prohibit waiting by any vehicle for the purpose of trading, unless the goods are immediately delivered at or taken into premises adjacent to the vehicle, on any verge or lay-by adjacent to the said main carriageway.

The prohibition imposed by the Order will not apply:

- (a) To a vehicle waiting upon the direction or with the permission of a police constable in uniform;
- (b) So as to prevent a vehicle from being used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road or of any of the service therein;
- (c) To a vehicle being used for fire brigade, ambulance or police purposes;
- (d) To a vehicle being used for the purpose of delivery or collecting postal packets;
- (e) To a vehicle being used by or on behalf of a local authority for the purpose of collecting household refuse or clearing cesspools;
- (f) To a vehicle waiting while any gate or other barrier at the entrance to premises to which the vehicle requires access or from which it has emerged is being opened or closed, if it is not reasonably practicable for the vehicle to wait elsewhere; and
