##### ACQUISITION OF LAND (AUTHORISATION PROCEDURE) ACT 1946

*The M.25 South Orbital Motorway (Egham-Thorpe Section Side Roads) Order 197*

*The London-Penzance Trunk Road (A.30) (Egham Diversion) Order 197*

*The M.25 Motorway (Egham-Lyne Section) Compulsory Purchase Order (No. CSE ) 19*

Notice is hereby given that Public Local Inquiries will be held by Mr. F. H. Carr, C.B.E., M.T.P.I., Dip.T.P. (a person appointed by the Secretary of State for the Environment for the purpose) beginning at 10.30 a.m. on Tuesday 13th June 1972, at the Hythe Social Centre, Thorpe Lea Road, Egham, Surrey, in connection with the Orders mentioned below, when representations from persons who have objected to the said proposals and from any other persons who desire to appear, will be heard.

The Orders which have been prepared in draft by the Secretary of State under the above-mentioned Acts are named below:

1. The M.25 South Orbital Motorway (Egham-Thorpe Section Side Roads) Order 197 (notice of which was published on 14th December 1971). This is an Order under sections 13 and 18 of the Highways Act 1959, section 27 of the Local Government Act 1966 and section 62 of the Highways Act 1971, which, if made, will authorise the Secretary of State:

- (a) to improve, raise, lower, or otherwise alter highways,
- (b) to stop up highways,
- (c) to construct new highways,
- (d) to stop up private means of access to premises, and
- (e) provide new means of access to premises,

all between Egham and Thorpe in the County of Surrey.

2. The London-Penzance Trunk Road (A.30) (Egham Diversion) Order 197 (notice of which was published on 14th December 1971). This is an Order under sections 7 and 44 of the Highways Act 1959, section 27 of the Local Government Act 1966 and section 68 of the Highways Act 1971, which, if made, will authorise the Secretary of State to construct along the route described in the Schedule to that Order a new road as a diversion of the A.30 Trunk Road at Egham in the County of Surrey and will provide for the said road to become a trunk road on the date when the Order comes into operation.

3. The M.25 Motorway (Egham-Lyne Section) Compulsory Purchase Order (No. CSE ) 19 (notice of which was published on 24th February 1972 is an Order under sections 214 and 215 of the Highways Act 1959, sections 44, 47 and 51 of the Highways Act 1971 and section 1 of the Acquisition of Land (Authorisation Procedure) Act 1946, which if made, will authorise the Secretary of State to compulsorily purchase the land described therein for the following purposes:

- (a) the construction of a new motorway and motorway interchange in the Urban District of Egham and the Urban District of Chertsey in the County of Surrey in pursuance of the M.25 South Orbital Motorway (Egham-Chertsey Section) Scheme 1971 and the M.3/M.25 Motorways (Thorpe Interchange) Connecting Roads Scheme 1971;
- (b) the construction of a new trunk road in the Urban District of Egham in the County of Surrey in pursuance of the London-Penzance Trunk Road (A.30) Egham Diversion) Order 197, and
- (c) the construction and improvement of highways and provision of new means of access

to premises in the Urban District of Egham and the Urban District of Chertsey in the County of Surrey in pursuance of the M.25 South Orbital Motorway (Egham-Thorpe Section Side Roads) Order 197.

Copies of the above-mentioned Schemes and draft Orders together with relevant plans have been deposited at the Department of the Environment, 2 Marsham Street, London S.W.1, and at the offices of the South Eastern Road Construction Unit, Federated House, London Road, Dorking, Surrey; and of the South Eastern Road Construction Unit (Surrey County Sub-Unit), 28-30 High Street, Guildford, Surrey; the Surrey C.C., County Hall, Kingston upon Thames, Surrey; the Egham U.D.C., Council Offices, High Street, Egham, Surrey; the Chertsey U.D.C., Council Offices, Station Road, Addlestone, Surrey; the Egham Public Library, High Street, Egham, Surrey; the New Haw Branch Library, The Broadway, New Haw, Byfleet, Surrey; the Chertsey Branch Library, Guildford Street, Chertsey, Surrey, and the Egham Branch Library, Station Parade, Virginia Water, Surrey, where they may be inspected free of charge at all reasonable hours.

Proceedings on the above-mentioned draft Orders are being taken concurrently—see section 53 of the Highways Act 1971.

The Secretary of State hereby directs that any person who intends at the Inquiries to submit that any highway or proposed highway to which the draft Orders or any of them relate should follow an alternative route, or that instead of improving, diverting or altering a highway to which the draft Diversion Order and Side Roads Order or either of them relate a new highway should be constructed on a particular route, shall send to him at the South Eastern Road Construction Unit, Federated House, London Road, Dorking RH4 1SZ, not later than 30th May 1972, sufficient information about the alternative route or the route of the new highway, as the case may be, to enable it to be identified. Failure to comply with this direction will entitle the Secretary of State and the person holding the Inquiries to disregard so much of any objection as consists of such a submission.

Plans showing alternative proposals submitted to date by objectors may be seen at the offices of the South Eastern Road Construction Unit, Federated House, London Road, Dorking, and of their Surrey County Sub-Unit, 28-30 High Street, Guildford, Surrey.

Persons wishing to make representations in connection with the above-mentioned matters should attend or be represented at the Inquiries.
