The Queen has been pleased to issue Her Majesty's Letters Patent under the Great Seal of the Realm in the form following:—

ELIZABETH THE SECOND by the Grace of God of the United Kingdom of Great Britain and Northern Ireland and of Our other Realms and Territories Queen Head of the Commonwealth Defender of the Faith to all Archbishops Dukes Marquesses Earls Viscounts Bishops Barons Baronets Knights Citizens and Burgesses and all other Our faithful Subjects whatsoever to whom these Presents shall come Greeting Whereas it is Our intention to be absent from Our United Kingdom for the purpose of visiting the Republic of France And Whereas by the enactments known as the Regency Acts 1937 to 1953 it is (amongst other things) enacted

that in the event of Our absence or intended absence from Our United Kingdom We may in order to prevent delay or difficulty in the despatch of public business by Letters Patent under the Great Seal delegate for the period of that absence to Counsellors of State such of Our Royal functions (except the power to dissolve Parliament otherwise than on Our express instructions and the power to grant any rank title or dignity of the peerage) as may be specified in the Letters Patent And Whereas the persons described by the said enactments as the Counsellors of State to be named in such Letters Patent are as follows that is to say Our most dearly beloved Husband and most faithful Counsellor Prince Philip Duke of Edinburgh Our most dearly beloved Mother Queen Elizabeth the Queen Mother Our most dearly beloved Son Charles Philip Arthur George Prince of Wales Knight of Our Most Noble Order of the Garter Our most dearly beloved Daughter Princess Anne Elizabeth Alice Louise Our most dear and entirely beloved Sister Princess Margaret Rose Countess of Snowdon Lady of the Imperial Order of the Crown of India Dame Grand Cross of Our Royal Victorian Order and Our most dear and entirely beloved Uncle and most faithful Counsellor Prince Henry William Frederick Albert Duke of Gloucester Knight of Our Most Noble Order of the Garter Knight of Our Most Ancient and Most Noble Order of the Thistle Knight of Our Most Illustrious Order of Saint Patrick Great Master and Principal Knight Grand Cross of Our Most Honourable Order of the Bath Knight Grand Cross of Our Most Distinguished Order of Saint Michael and Saint George Knight Grand Cross of Our Royal Victorian Order subject however to provisions enabling Us by the Letters

Patent to except from among the number of those Counsellors any person who is absent from Our United Kingdom or intends to be so absent during the period of Our absence And Whereas Our Husband Prince Philip Duke of Edinburgh intends to accompany Us during Our absence from Our United Kingdom And Whereas the Prince of Wales is absent from Our United Kingdom at the date hereof and Princess Margaret Countess of Snowdon intends to be so absent during part of the period of Our absence Know Ye that by virtue of the said enactments We do hereby delegate for the period of Our absence to the said Counsellors of State (excepting during their absence from Our United Kingdom those who are or intend to be so absent as hereinbefore recited) the Royal functions specified in the first Schedule annexed hereto to be exercised jointly by not less than two of their number subject to the following exceptions and conditions namely That they the said Counsellors of State shall not have power to dissolve Parliament otherwise than on Our express instructions or to grant any rank title or dignity of the peerage That they shall not receive any homage required to be done to Ourselves That they shall not approve or sign any warrant fiat submission or other document for which Our approval or signature is required for or in connection with any of the matters described in the Second Schedule annexed hereto and That if We signify or it appears to them that they should not act in any matter or for any purpose without Our previous special approval they shall not act in that matter or for that purpose without that approval Commanding all and singular Archbishops Dukes Marquesses Earls Viscounts Bishops Barons Baronets Knights Citizens and Burgesses and all other Our Officers Ministers and Subjects that in everything appertaining to the matters aforesaid they be attendant counselling and helping the said Counsellors of State as it behoves them In Witness whereof We have caused these Our Letters to be made Patent Witness Ourselves at Westminster the eleventh day of May in the twenty-first year of Our Reign

WALSALL COUNTY BOROUGH COUNCIL
*The Walsall (No. 14) (Delves) Smoke Control
Order, 1972*

Notice is hereby given that the Council of the County Borough of Walsall in exercise of the powers conferred on them by Section II of the above-mentioned Act on the 24th April 1972 made an Order entitled the Walsall (No. 14) (Delves) Smoke Control Order, 1972 declaring the area described in the Schedule hereto to be a smoke control area which Order is about to be submitted to the Secretary of State for the Environment for confirmation.

Subject to the exemptions provided by the Order and by virtue of Section II (4) of the Act if, on any day after the Order has come into operation, smoke is emitted from a chimney of any building within the smoke control area the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £10 unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels, gas and electricity.

If confirmed the order will not come into operation before 1st September 1973 or before a later date determined by the Secretary of State for the Environment.

Copies of the order and of the map referred to therein may be inspected free of charge at The Town Clerk's Office, The Council House, Walsall at all reasonable times during the period of seven weeks from the 12th May 1972.

Within the said period any person who will be affected by the Order may by Notice in writing to the Secretary of State for the Environment, Queen Anne's Chambers, Tothill Street, London, S.W.1 object to the confirmation of the Order.

1. *Coach Park, London Road*

(i) Increase the charge to £0.20 per day or part thereof between the hours of 9 a.m. and 6 p.m. during the season (Good Friday to the first Sunday in October) for the parking of passenger vehicles as defined in the Order of 1970 on the land on the east side of London Road and to the west of the footpath running from Lyon Street northwards to Upper Bognor Road which said piece of land is bounded on the north by the boundary wall separating the said land from the property belonging to the Sussex Police Authority the said land having an area of 0.12 acres or thereabouts and a depth from the said boundary wall of 18 feet or thereabouts;

(ii) *Fitzleet* (a) Increase the charge to £0.20 per day or part thereof between the hours of 9 a.m. and 6 p.m. on Sundays and Public Holidays during the season (Good Friday to the first Sunday in October) and (b) reduce from two hours to one hour or part thereof after the first half-hour, between the hours of 8.30 a.m. and 6 p.m. on weekdays being the period

for which a charge of £0.05 will be made, for the parking of passenger and commercial vehicles as defined in the Order of 1970 on land to the west of Bedford Street and to the east of Queensway such land having an area of 1.36 acres or thereabouts;

(iii) *Belmont* (a) Increase the charge to £0.20 per day or part thereof between the hours of 9 a.m. and 6 p.m. on Sundays and Public Holidays during the season (Good Friday to the first Sunday in October) and (b) reduce from two hours to one hour or part thereof after the first half-hour, between the hours of 8.30 a.m. and 6 p.m. on weekdays being the period for which a charge of £0.05 will be made, for the parking of passenger and commercial vehicles as defined in the Order of 1970 on land to the south of Belmont Street west of the premises known as Maitland Cottage and extending to the Rex Buildings such land having an area of 1.00 acres or thereabouts.
