

## TEESSIDE COUNTY BOROUGH COUNCIL

*The Teesside (John Street/Norton Road Link Road Stockton) Compulsory Purchase Order, 1972*

Notice is hereby given that the Teesside County Borough Council in exercise of the powers conferred on them by the above-mentioned Acts on the 30th day of May 1972, made a Compulsory Purchase Order entitled *The Teesside (John Street/Norton Road Link Road Stockton) Compulsory Purchase Order 1972*, which is about to be submitted to the Secretary of State for the Environment for confirmation, authorising them to purchase compulsorily for the purpose of the construction of a new length of highway running in a north-easterly direction from Bishopton Lane, Stockton-on-Tees, to Norton Road, Stockton-on-Tees incorporating a link road from the said new length of highway to Langley Street, Stockton-on-Tees and the improvement of John Street, Stockton-on-Tees between its junction with Mill Street West and Bishopton Lane aforesaid and involving the improvement of Mill Street West aforesaid, Bishopton Lane aforesaid, Langley Street aforesaid and Norton Road aforesaid, the land described in the Schedule hereto.

A copy of the Order and the map referred to therein have been deposited at the Town Clerk's Office, Municipal Buildings, Middlesbrough, Teesside and may be seen there at all reasonable hours.

Any objection to the Order must be made in writing and addressed to the Secretary of State for the Environment, Wellbar House, Gallowgate, Newcastle upon Tyne, NE1 4TX before the 26th day of June 1972, and should state the grounds of objection.
