The Lords Commissioners of Her Majesty's Treasury hereby give notice that they have made an Order under sections 3 (6) and 13 of the Import Duties Act 1958.

Viz.: The Import Duties (Temporary Exemptions) (No. 5) Order 1972.

This Order provides for the temporary exemption from import duty, until the 16th July 1972, of fresh, chilled or frozen beef and veal.

The Order comes into operation on 7th June 1972 and has been published as Statutory Instruments 1972 No. 849.

#### THE TOWN AND COUNTRY PLANNING ACT 1971

The Secretary of State for Wales hereby gives notice that he proposes to make an Order under section 209 of the Town and Country Planning Act 1971 to authorise the stopping up of a length of Llay Villa Lane, Llay in the Rural District of Wrexham in the County of Denbigh, to enable development consisting of sand and gravel extraction to be carried out in accordance with planning permission granted under Part III of the said Act.
