The Lords Commissioners of Her Majesty's Treasury hereby give notice that they have made an Order under sections 3 (6) and 13 of the Import Duties Act 1958.

Viz.: The Import Duties (Temporary Exemptions) (No. 6) Order 1972.

This Order provides that the goods listed in Schedule 1 shall be temporarily exempt from import duty, and those listed in Schedule 2 shall continue to be exempt from import duty, both until 1st January 1973 or, in the case of certain items, until such earlier day as is specified.

As regards the exemption for equipment for use in aircraft under heading 85.15, apparatus of a type approved by the Civil Aviation Authority is listed in Civil Aviation Publication CAP 208, Airborne Radio Apparatus Vol. 2, published by Her Majesty's Stationery Office. This publication is subject to amendment, and confirmation that apparatus is of a type approved at the date of this Order should be obtained from the Civil Aviation Authority, Controllerate of National Air Traffic Services, Tels. N2(c), 19-29 Woburn Place, London, WC1H 0LX.

The Order comes into operation on 4th July 1972 and has been published as Statutory Instruments 1972 No. 951.

Whereas:

(1) Pursuant to section 295 of the Companies Act 1929 Harefield (Middleton) Estate Limited (hereinafter called "the Company") became dissolved on the 3rd October 1938.

(2) It is alleged that immediately before such dissolution the property disclaimed by this notice was vested in the Company and may by virtue of section 296 of the Companies Act 1929 be deemed to have become bona vacantia and to have vested in the Crown.
