WAGES COUNCIL

WAGES COUNCIL ACT 1959

Retail Drapery, Outfitting and Footwear Trades Wages Council (Great Britain)

The Retail Drapery, Outfitting and Footwear Trades Wages Council (Great Britain) hereby gives notice of its intention to submit to the Secretary of State for Employment proposals for (1) increasing the statutory minimum remuneration set out in the Wages Regulations (Retail Drapery, Outfitting and Footwear) Order 1972 (Order R.D.O. (60)); and (2) the revocation of Order R.D.O. (60). Particulars of the proposals are contained in the Wages Council's Notice R.D.O. (61) which may be obtained on application to the Secretary of the Wages Council at the address given below.

The Wages Council will consider any written representation with respect to the above-mentioned proposals if made to it within 14 days from 30th June 1972. It is desirable that persons making objections should state the precise nature of their objections and quote the number of the Wages Council's Notice of Proposals R.D.O. (61).

TOWN AND COUNTRY PLANNING ACT 1971
