The Holywell Urban (Public Footpath No. 21) Public Path Diversion Order 1972

Notice is hereby given that on the 26th June 1972, the Holywell Urban District Council confirmed the above-named Order.

The effect of the Order as confirmed is to divert the public right of way running from Moor Lane in a north-westerly direction to the north-western corner of field 5079 to a line running from Moor Lane along the footpath of a proposed new estate road in a north-westerly direction to the north-western corner of field 5079.

The Amendment relates to the Newport Comprehensive Development Area CDA 1 and CDA 2 as submitted by the Local Planning Authority. The Secretary of State has modified the proposals submitted by the Local Planning Authority by deleting

the whole of area CDA 1 and by deleting the following residential properties from the area CDA 2:
14-16 Cross Street;
14-24 even and 11-25 odd New Street;
17-21 Chapel Street.
