

the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which is to revoke the County of Denbigh (Traffic Regulation) Order 1952, The Trunk Road (Well Street, Ruthin) (Prohibition of Waiting) Order, 1962 and The Trunk Road (Castle Street, Ruthin) (Restriction of Waiting) Order 1967; and to prohibit waiting between the hours of 8 a.m. and 6 p.m.:

- (1) in any length of road or on the side of road, specified in Schedule 1 to this notice; or
- (2) on the side of road specified in Schedule 2 to this notice:
  - (a) for a longer period than 30 minutes, or
  - (b) if a period of less than 30 minutes has elapsed since the termination of the last period of waiting (if any) of the vehicle on that side of road during the said hours.

Exemptions are provided in the Order to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle; to enable goods to be loaded on to or unloaded from the vehicle; to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road or the services therein; or to enable the vehicle to be used in the service of a local authority in pursuance of statutory powers or duties.

Exemptions are also provided in the Order to enable a vehicle to wait in that side of road specified in Schedule 2 below if that vehicle is an invalid carriage; a vehicle which has been issued to a disabled person by the Welsh Office in lieu of an invalid carriage; or a vehicle which bears at the front and rear in conspicuous positions badges issued to the driver of any local authority in accordance with the provisions of the Disabled Persons (Badges for Motor Vehicles) Regulations 1971 or a badge having effect under those Regulations as if it were a disabled person's badge.

If you wish to question the validity of the Order or of any provision contained therein on the grounds that it is not within the powers conferred by the Road Traffic Regulations Act 1967, as amended by Part IX of the Transport Act 1968 or on the grounds that any requirement of that Act or of any instrument made under it, has not been complied with in relation to the Order, you may within 6 weeks from the 28th June 1972, apply to the High Court for the suspension or quashing of the Order.

#### SCHEDULE 1

*Lengths and a side of a length of the Dolgellau—South of Birkenhead Trunk Road (A.494) (hereinafter referred to as "the Trunk Road") at Ruthin in the County of Denbigh*

1. That length of the trunk road, known as Castle Street, which extends from its junction with Dog Lane to its junction with Upper Clwyd Street.
2. That length of the trunk road, known as Market Place, which extends from its junction with St. Peter's Square to its junction with that length of the trunk road, known as Well Street.
3. That length of the trunk road, known as Well Street, which extends from its junction with that length of the trunk road known as Market Place to a point 20 yards east of its junction with Wynnstay Road.
4. The north side of that length of the trunk road, known as Well Street, which extends from a point 20 yards east of its junction with Wynnstay Road to its junction with Station Road (B.5105).
5. That length of the trunk road, known as Well Street, which extends from its junction with Station Road (B.5105) to its junction with Llanfair Street (A.525).

#### SCHEDULE 2

The south side of the length of the Dolgellau—South of Birkenhead Trunk Road (A.494), known as Well Street, at Ruthin in the County of Denbigh, which extends from a point 20 yards east of its junction with Wynnstay Road to its junction with Station Road (B.5105).
