### TOWN AND COUNTRY PLANNING ACT 1971

The Secretary of State for the Environment hereby gives notice that he has made an Order under section 209 of the above Act entitled "The Stopping up of Highways (City and County Borough of Coventry) (No. 1) Order 1972" authorising the stopping up of an area of footpath on the north-east corner of Park Street and Foleshill Road, Coventry, Warwickshire.

Copies of the Order may be obtained, free of charge, on application to the Department of the Environment at the Office of the Regional Controller (Roads and Transportation), West Midland Region, Five Ways House, Islington Row, Birmingham, B15 1SP (quoting WMRT 402/35/1/015) and may be inspected at all reasonable hours at the Offices of the Clerk to the Coventry City and County Borough Council, The Council House, Coventry.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the grounds that it is not within the powers of the above Act or that any requirement of that Act or of any regulation made thereunder has not been complied with in relation to the Order, may, within 6 weeks of the 13th July 1972, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

### TOWN AND COUNTRY PLANNING ACT 1971

The Secretary of State for the Environment hereby gives notice that on the application of the Southwark London Borough Council, he proposes to make an Order under section 212 of the above Act to provide for the extinguishment of any right which persons may have to use vehicles on a length of Linsey Street, Bermondsey, London S.E.16.

The proposed Order will contain provisions for permitting the use of that highway by vehicles being used:

- (a) for police, ambulance or fire brigade purposes;
- (b) on behalf of a statutory undertaker or the Post Office and engaged upon the laying, erection, inspection, maintenance, alteration, repair, renewal or removal under, in, on, over, along or across the highway of any main, pipe, conduit, wire, cable or other apparatus for the supply of gas, water, electricity or of any telegraph line as defined in the Telegraph Act 1878;
- (c) in accordance with a special authorisation in writing for that use given by or on behalf of the Southwark London Borough Council;

and where the vehicle is:

- (d) an invalid carriage (as defined in the Road Traffic Act 1960), whether propelled electrically, mechanically or by hand; or
- (e) a vehicle which has been issued to a disabled person by the Department of Health and Social Security in lieu of an invalid carriage; or
- (f) a disabled person's vehicle which displays a disabled person's badge issued by any local authority in accordance with the provisions of the Disabled Persons (Badges for Motor Vehicles) Regulations 1971 or a badge having effect under those regulations as if it were a disabled person's badge.

During 28 days from the 14th July 1972 copies of the draft Order and relevant plan may be inspected at the Town Hall, Peckham Road, London S.E.5 and may be obtained free of charge from the Secretary of State (quoting TTP 44/L8/03) at the address stated below.

Within the above-mentioned period of 28 days, any person may by notice to the Secretary of State (Ref. TTP 44/L8/03), 2 Marsham Street, London, SW1P 3EB, object to the making of the Order.
