TOWN AND COUNTRY PLANNING ACT 1971

The Secretary of State for the Environment hereby gives notice that he has made an Order under section 209 of the above Act entitled "The Stopping up of Highways (City and County Borough of Bath) (No. 2) Order 1972" authorising the stopping up of lengths of Old Orchard and Paradise Street, Bath, Somerset, and requiring the provision of a new footpath and a new road.
