THE TRANSPORT HOLDING COMPANY (CAPITAL DEBTS) ORDER 1972 (S.I. 1972 No. 1024)

1. Under the Transport Act 1968 the Secretary of State for the Environment has made Orders, coming into operation on 4th August 1972, which:

(i) prescribe the amount of the commencing capital debt of the National Bus Company at £97,625,178. This sum represents the assets taken over by the Company from the Transport Holding
