GRIMSBY COUNTY BOROUGH COUNCIL

 - (g) The easterly side of Heneage Road for 40 yards north of its junction with Eleanor Street.
- 2. To introduce no waiting between 8 a.m. and 6 p.m. from Monday to Saturday on the following lengths of road:

- (a) The westerly side of Victoria Street South from 15 yards north of Upper Spring Street to 45 yards north of Upper Spring Street;
- (b) Both sides of Marklew Avenue for 60 yards south of its junction with Cromwell Road;
- (c) Both sides of Cleethorpe Road from (approximately) its junction with Trinity Street to 15 yards west of its junction with Hilda Street.
- 3. To prohibit vehicles making U-turns in Riby Square.
- 4. To revoke the byelaws relating to parking places in streets. These are not necessary since the regulations allowing parking without lights came into effect.
- 5. This Order forms an amendment to an existing Order, and the usual exemptions apply to permit the waiting of vehicles for specified purposes (including loading and unloading of goods). The provisions of any Order which are contrary to these proposals will be revoked.
- 6. A draft of the Order, and a map showing its full extent and effect, and the Council's statement of its reasons for making the Order, may be inspected at my office, during normal office hours. Any objections to the Order should be made in writing to me at the undermentioned address, and should state the grounds of objection.
