### WATER RESOURCES ACT, 1963

#### NOTICE OF APPLICATION FOR LICENCE TO OBSTRUCT OR IMPEDE THE FLOW OF AN INLAND WATER BY MEANS OF IMPOUNDING WORKS

Notice is hereby given that an application is being made to the Severn River Authority by L. B. Thwaites for a licence to obstruct or impede the flow of a Tributary of the Tach Brook by means of alterations to two existing impounding works forming them into one reservoir at N.G.R. SP. 359 577 in Chesterton and Kingston Parish, Warwickshire.

The object of impounding water by means of the works is formation of fish pools and wild life refuge.

The capacity of the reservoir at overflow level will be approximately 4.5 million gallons.

A copy of the application and of any map, plan or other document submitted with it may be inspected free of charge at Hurdiss Farm, Harbury, Leamington Spa, Warwickshire, at all reasonable hours during the period 11th August 1972 until 8th September 1972.

#### LITTLE LEVER URBAN DISTRICT COUNCIL

##### CLEAN AIR ACT, 1956

##### *The Little Lever No. 2 Smoke Control Order, 1972*

Notice is hereby given that the Little Lever Urban District Council in exercise of the powers conferred on them by Section 11 of the above-mentioned Act on the 28th March 1972, made an Order entitled the Little Lever No. 2 Smoke Control Order, 1972, declaring the area described in the Schedule hereto to be a smoke control area, which Order is about to be submitted to the Secretary of State for the Environment for confirmation.

Subject to the limitations and exemptions provided by the Order and by virtue of Section 11 (4) of the Act, if, on any day after the Order has come into operation, smoke is emitted from a chimney of any

building within the smoke control area the occupier of that building shall be guilty of an offence, and liable to a fine not exceeding £20 unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels, gas and electricity.

If confirmed the Order will not come into operation before the 1st October 1973, or before a later date determined by the Secretary of State for the Environment.

Copies of the Order and of the Map referred to therein may be inspected free of charge at the Council Offices, Market Street, Little Lever, Bolton BL3 1HJ, at all reasonable times during the period of six weeks from the 24th August 1972.

Within the said period any person who will be affected by the Order may by Notice in writing to
