*Gloucestershire County Council (CCA 58 Cam) Public Path Diversion Order, 1972*

*Oxfordshire County Council (Footpath No. 15, Enstone) Public Path Diversion Order 1972*

Notice is hereby given that the above-named Order (hereinafter referred to as "the Order") made on the 18th August 1972, is about to be submitted to the Secretary of State for the Environment for confirmation or to be confirmed by the Oxfordshire County Council as an unopposed Order.
