TOWN AND COUNTRY PLANNING ACT 1971

The Secretary of State for Wales hereby gives notice that he proposes to make an Order under section 209 of the Town and Country Planning Act, 1971, to authorise the stopping up of those lengths of highway specified in the Schedule to this notice, to enable development consisting of a derelict land reclamation scheme to be carried out in accordance with a planning permission granted by Monmouthshire County Council.

The proposed Order will require the provision of a new highway maintainable at the public expense, for which the highway authority is to be the Abergillery Urban District Council.
