The effect of the Order is to extend the existing restrictions on loading/unloading by vehicles in that length of the Folkestone-Brighton-Southampton-Dorchester-Honiton Trunk Road (A.27) known as High Street in the Borough of Lewes, Sussex. The additional restriction in High Street applies as follows:

Loading/Unloading Prohibited between 8 a.m and 10 a.m.: 4 p.m. and 6 p.m. on Mondays to Saturdays inclusive

 Both sides, from a point 190 ft. east of its junction with Westgate Street to a point 45 ft. east of its junction with Watergate Lane;
 North side, from a point 45 ft. east of its junction with Watergate Lane to a point 150 ft. west of its junction with the west side of Fisher

Exceptions have been provided in the Order to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle, to enable goods to be loaded on to or unloaded from the vehicle (except as otherwise specified above), or to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road or the services therein.

Any person who desires to question the validity of, or of any provision contained in, the Order, on the ground that it is not within the powers with respect to the Order conferred by the above Act, or on the to the Order conferred by the above Act, or on the ground that any requirement of, or of any instrument made under, any provision of that Act has not been complied with in relation to the Order, may within 6 weeks of 28th September 1972, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.
