#### SCHEDULE

Lengths of Highway to be Stopped-up (All distances are approximate)

The highways to be stopped-up are at Ystradgynlais

in the County of Brecom.

They are shown by zebra hatching on the deposited

plan and are:

1. That length of Gorof Road (A4067) which extends from a point 70 yards north of the northern boundary of the Masons' Arms in a north-easterly direction for a distance of 205 yards, marked A-B on the deposited plan.

2. That side of unnamed unclassified road No. 391

which extends:

(a) from a point 47 yards north-east of number 8 James Street in an easterly direction for a dis-tance of 120 yards, marked C-D on the deposited plan; and

(b) from a point 45 yards west of No. 1 Chapel Houses in a westerly direction for a distance of 80 yards, marked E-F on the deposited plan.

3. That length of unnamed road which extends from the northern abutment of the river bridge at Cwm-Tawe in a northerly direction for a distance of 50 yards, marked G-H on the deposited plan.

4. That length of unnamed roads which extends from a point 10 yards north of the northern abutment of the river bridge at Cwm-Tawe in a north-westerly direction for a distance of 60 yards, marked J-K on the deposited plan.

5. That length of unnamed road which extends from a point 50 yards north of the northern abutment of the river bridge at Cwm-Tawe in a westerly direction for a distance of 50 yards, marked H-K on the deposited plan.

6. That length of footpath No. 54 which extends:

(a) from a point 30 yards west of the western extremity of the Yniscedwyn Arms Hotel in a

south-westerly direction for a distance of 21 yards, marked L-M on the deposited plan; and (b) from a point at the rear of No. 95 Gorof Road in a south-westerly direction for a distance of 270 yards, marked N-P on the deposited plan.

The Trunk Road (Coracle Way and Carmarthen Bridge, Carmarthen) (One-Way Traffic) Order, 1972 Notice is hereby given that the Secretary of State has made an Order under section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which is

(1) No person shall cause any vehicle to proceed in a direction other than from west to east in that length of the London-Fishguard Trunk Road (A48), known as Coracle Way, at Carmarthen in the County of Carmarthen;

(2) No person shall cause any vehicle to proceed in a direction other than from north to south in that length of the London-Fishguard Trunk Road (A48), known as Carmarthen Bridge, at Carmarthen in the County of Carmarthen.

The Order replaces the present experimental restrictions and will be reviewed in connection with any scheme for a second permanent crossing of the river.

The Secretary of State for Wales hereby gives notice that he proposes, on the application of the Merthyr Tydfil County Borough Council, to make an Order under section 212 of the Town and Country Planning Act 1971 for extinguishing any rights which persons may have to use vehicles on those lengths of road specified in the Schedule to this notice.
