The Trunk Road (Great North Road and Castle Terrace, Milford Haven) (Prohibition and Restriction of Waiting) Order 1972.

Notice is hereby given that the Secretary of State intends to make an Order under section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which will be to prohibit waiting:

- (a) on any of the sides of road specified in Schedule 1 to this notice; and
(b) for longer than 1 hour in any period of 2 hours between the hours of 8 a.m. and 6 p.m. on the side of road specified in Schedule 2 to this notice.

Exceptions will be provided in the Order to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle, to enable goods to be loaded on to or unloaded from the vehicle, to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road or the services therein, to enable the vehicle to be used in the service powers or duties, or to enable a vehicle to take in of a local authority in pursuance of statutory powers or duties, or to enable a vehicle to take in petrol, oil, water or air from any garage situated on or adjacent to any of the said sides of road.

The restrictions referred to in item (b) will not apply to an invalid carriage, a vehicle issued to a disabled person by the Welsh Office in lieu of an invalid carriage, a vehicle left by the driver thereof, who is a person who on account of his severe physical disability has been issued with an exemption by Pembrokeshire County Council, and that exemption is displayed on the vehicle in a conspicuous position, or to a vehicle left by the driver thereof who has been issued with a disabled person's badge under the disabled person's scheme and the badge is placed in a conspicuous position on that vehicle.

A copy of the proposed Order together with a plan may be seen at the offices of the Milford Haven Urban District Council, Town Hall, Milford Haven, during normal office hours.

SCHEDULE 1

Sides of the Haverfordwest—Milford Haven Trunk Road (A.4076) (hereinafter referred to as "the trunk road"), at Milford Haven in the County of Pembrokeshire.

1. The east side of that length of the trunk road, known as Great North Road, which extends:

- (a) from its junction with Hamilton Terrace to a point 133 yards south of its junction with Imperial Terrace, a distance of approximately 483 yards; and
(b) from a point 20 yards north of its junction with Imperial Terrace to its junction with Coombs Road, a distance of approximately 53 yards.

2. The west side of that length of the trunk road, known as Great North Road, which extends:

- (a) from its junction with Hamilton Terrace to a point 15 yards north of that junction;
(b) from a point 15 yards south of its junction with Charles Street, B.4326, to a point 15 yards north of its junction with Robert Street, a distance of approximately 103 yards;
(c) from a point 15 yards south of its junction with Warwick Road to a point 26 yards north of that junction, a distance of 41 yards;
(d) from a point 15 yards south of its junction with Greville Road to a point 15 yards north of that junction, a distance of 30 yards;

- (e) from a point 50 yards north of its junction with Greville Road to a point 143 yards south-west of its junction with Marble Hall Road, a distance of approximately 87 yards; and
(f) from a point 27 yards north-east of its junction with Marble Hall Road to a point opposite its junction with Coombs Road, a distance of approximately 53 yards.

SCHEDULE 2

Side of the Haverfordwest—Milford Haven Trunk Road (A.4076) (hereinafter referred to as "the trunk road"), at Milford Haven in the County of Pembrokeshire.

The west side of that length of the trunk road, known as Great North Road, which extends:

- (a) from a point 15 yards north of its junction with Hamilton Terrace to a point 15 yards south of its junction with Charles Street, a distance of approximately 40 yards;
(b) from a point 15 yards north of its junction with Robert Street to a point 15 yards south of its junction with Warwick Road, a distance of approximately 18 yards;
(c) from a point 60 yards north of its junction with Warwick Road to a point 15 yards south of its junction with Greville Road, a distance of approximately 50 yards; and
(d) from a point 15 yards north of its junction of Greville Road to a point 50 yards north of that junction, a distance of 35 yards.
