Notice is hereby given that the Secretary of State for Wales has appointed Mr. T. V. Burrows, C.Eng.F.I.C.E., F.I.Mun.E., to hold a Public Local Inquiry commencing at 10.30 a.m. on Tuesday 12th December 1972, at The Welfare Hall, Pyle, Glamorgan in connection with the above mentioned Schemes and Order.

The first said Scheme would, if made,

- (a) provide that the road which the Secretary of State proposes to construct for the exclusive use of traffic of Classes I and II of the classes of traffic set out in Schedule 4 to the Highways Act 1959 (as amended) will be a special road about 12:53 kilometres in length between Pencoed in the County of Glamorgan and Stormy Down in the said County ;
- (b) provide for the special road to become a trunk road as from the date when the Scheme comes into operation.

The second said Scheme would, if made,

- (a) provide 4 special roads as connecting roads between the above mentioned Special Road and the realigned Bridgend to Blackmill road at Cefn Hirgoed; and (b) provide for the special roads to become trunk
- roads as from the date when the Scheme comes into operation.

The said Order would, if made, authorise the Secretary of State:

(a) (i) to improve, raise, lower or otherwise alter highways

(ii) to stop up highways (iii) to construct new highways (iv) to stop up private means of access to premises, and

(v) to provide new means of access to premises all on or in the vicinity of the above-mentioned special roads and

(b) provide for the transfer of each of the said new highways to the County Council of Glamorgan, as from 1st April next, after the date on which the Secretary of State notifies that authority that the new highways have been completed and are open for through traffic.
