Employment hereby gives notice that he proposes to make Special Regulations amending the Chromium Plating Regulations 1931. The Regulations will prescribe, as an alternative to the provision of efficient exhaust ventilation at vessels at which electrolytic chromium processes are carried on, the use of spray suppressant control methods. They will require the testing by an approved method of the efficiency of the exhaust ventilation or spray suppressant control at such vessels at least once in every 14 days by a responsible person appointed for the purpose by the factory occupier. The provisions of the 1931 Regulations requiring a fortnightly medical examination by the Appointed Factory Doctor of persons employed in processes involving contact with liquid from such vessels will be revoked. The Regulations will impose requirements for the keeping of a register in an approved form for recording the results of tests and for the keeping of a register in an approved form for recording the inspections of hands and forearms of employed persons by a responsible person.

Under section 9 of the Diseases of Animals Act 1950 (as amended by section 105 of the Agriculture Act 1970) the Minister of Agriculture, Fisheries and Food and the Secretary of State for Scotland have power to vaccinate any animal which is in an infected area for the purposes of that Act.

This Order, which came into operation on 27th October to facilitate the exercise of such power in relation to footand-mouth disease requires a person

October to facilitate the exercise of such power in relation to foot-and-mouth disease, requires a person responsible for "relevant animals"—that is to say cattle, sheep, goats and all other ruminating animals and swine—in an area which is in an infected area under the Foot and Mouth Disease (Infected Areas Restrictions) Order of 1938, on being informed of the Ministers' proposal to vaccinate such animals, to submit them for vaccination against foot-and-mouth disease in accordance with the requirements of an disease in accordance with the requirements of an authorised officer; and generally to render the latter such assistance as he may require to enable vaccination to be duly carried out.

A person on whom such a requirement is imposed must comply with the terms of any notice served on him at the time requiring him within 24 hours to state in writing for what other relevant animals within a radius of 10 miles he is also responsible.
