NOTICE OF CONFIRMATION OF PUBLIC PATH ORDER
TOWN AND COUNTRY PLANNING ACT, 1971
SECTION 210

The Borough of Radcliffe (Parish of Christ Church, Ainsworth—Footpath No. 12) Public Path Diversion Order, 1972.

Notice is hereby given that on the 23rd October 1972, the Radcliffe Borough Council confirmed the above-named Order.

The effect of the Order, as confirmed, is to divert that part of the footpath No. 12 Radcliffe, from a point 52 yards south-east of Ainsworth Hall Road, in an easterly direction to a point 144 yards from Ainsworth Hall Road, to a line running from the same point 52 yards south-east of Ainsworth Hall Road for 55 yards in a south-easterly direction roughly parallel to and slightly to the east of the existing footpath, then curving in an easterly direction and finally turning south for 33 yards, terminating at the same point 144 yards south-east of Ainsworth Hall Road.

Copies of the Order and the map contained in it have been deposited at the offices of the Town Clerk, Radcliffe Borough Council, Town Hall, Radcliffe, and may be inspected free of charge between the hours of 9 a.m. and 5 p.m. on weekdays up to and including the 7th December 1972.

This Order becomes operative as from the date on which it is certified by the Radcliffe Borough Council that the alternative highway has been created to their reasonable satisfaction in compliance with the provision of Article 2 of the Order, but if any person aggrieved by the Order desires to question the validity thereof or any provision contained therein on the grounds that it is not within the powers of the Town and Country Planning Act 1971 or on the grounds that any requirement of that Act or any regulation made thereunder has not been complied with in relation to the confirmation of the Order, he may under section 244 of the Town and Country Planning Act 1971 within 6 weeks from the 9th November 1972, make application for the purpose to the High Court.

WANDSWORTH LONDON BOROUGH

Notice is hereby given that the Wandsworth Corporation has by resolution of 10th October 1972 designated that area of Old Battersea in the London Borough of Wandsworth as described in the Schedule hereto and indicated on Plan No. TP/CA/28 as a conservation area under the provision of section 277 of the Town and Country Planning Act, 1971.

That part of Battersea comprising the area bounded on the north by St. Mary's Church, on the west by the River Thames from St. Mary's Church to the

Albion Wharf, then eastwards along the Slipway to its junction with Vicarage Crescent, then northwards along Vicarage Crescent to the southern boundary of Old Battersea House, then northwards along its eastern boundary to the rear of Eaton House, then in a generally easterly direction along the southern boundary of Sir Walter St. John's Grammar School to cross Battersea High Street into Trott Street to include the grounds of the Roman Catholic Church of the Sacred Heart, then in a westerly direction back to Battersea High Street, then northwards along Battersea High Street to the Printing Works occupying the sites of Nos. 39-43 Battersea High Street, then along its southern boundary to the rear of No. 37 Granfield Street, then in a north-westerly direction along the rear boundaries of Nos. 37-45 Granfield Street, continuing along the western boundaries of Nos. 121 and 123 Westbridge Road into Westbridge Road, then in a westerly direction along Westbridge Road to the eastern boundary of the "Raven" Inn P.H., then continuing in a generally north-westerly direction along the rear boundaries of Nos. 183-151 Battersea Church Road and then northwards along Battersea Church Road to St. Mary's Church.

Designation of Conservation Area at Staithes

Notice is hereby given that the County Council of the Administrative County of the North Riding of Yorkshire, as local planning authority, have determined that part of their area, namely that part of the village of Staithes in the Urban District of Loftus and the Rural District of Whitby which is more particularly described below, is an area of special architectural or historic interest the character or appearance of which it is desirable to preserve or enhance, and accordingly have designated the said area as a Conservation Area in pursuance of the provisions of section 277 of the Town and Country Planning Act 1971.

The part of Staithes which has been so designated is as follows:

The whole of the traditional settlement of Staithes.

On the seaward side the area extends from Sandy Wyke to Penny Nab. Inland, the boundary runs from Sandy Wyke to a point on Staithes Lane adjacent to but excluding the Staithes County School and from there to the southern side of St. Peter's Church. From that point it extends south to include Gun Gutter and then proceeds to Penny Nab along the southern edge of the cliff frontage.

A map defining the area which has been designated may be inspected during normal office hours at the office of the County Planning Officer, County Hall, Northallerton, the Area Planning Offices at 22 St. Hilda's Terrace, Whitby and at Westgate, Guisborough, the office of the Clerk of the Loftus Urban District Council, Council Offices, Loftus, and the office of the Clerk of the Whitby Rural District Council, Council Chambers, "Eskholme", Uppgang Lane, Whitby.
