SWANSEA CITY COUNCIL

The City of Swansea (Box Junctions and Prohibition of U-Turn) Order 1972

Notice is hereby given that the Council of the City of Swansea propose to make an Order under Section 1(1), (2), (3) and (3B) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968.

The Borough of Cleethorpes (St. Peter's Avenue) (Prohibition of Waiting) Order 1972

Traffic Regulation Orders—Caerleon Road Area

Notice is hereby given that on 1st November 1972, the Newport County Borough Council made three Orders under Sections 1(1), (2) and (3) and 84D(1) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968.

The Orders will come into operation on 20th November 1972. The effect of the Orders is as follows:

- (i) *The County Borough of Newport (Caerleon Road and Various Roads) (Prohibition and Restriction of Waiting) Order 1972*—Vehicles may not be left at any time on parts of the following roads: Annesley Road, Bath Street, Beaufort Road, Caerleon Road, Dean Street, Junction Road, Morden Road, Orchard Street, Richmond Road, Somerset Road, Stafford Road, St. Julian's Avenue, St. Julian's Road, The Moorings and York Road.
- (ii) *The County Borough of Newport (Caerleon Road, Duckpool Road and Various Roads) (Prohibition of Waiting and Restriction of Loading and Unloading) Order 1972*—Vehicles may not be left at any time on parts of the following roads: Annesley Road, Caerleon Road, Constance Street, Duckpool Road and Durham Road. Loading and unloading will also be prohibited between the hours of 8 a.m. and 9.30 a.m.; or 4.30 p.m. and 6 p.m. (except Sundays) on the same parts of roads.
- (iii) *The County Borough of Newport (Bishop Street and Caerleon Road) (Prohibition of Driving) Order 1972*—Vehicles may not enter or leave Bishop Street at its junction with Caerleon Road.

Exceptions will be included in Orders (i) and (ii) to permit waiting for the purposes of:

- (a) picking up and setting down passengers;
- (b) loading and unloading goods (Order (i) and part of Order (ii));
- (c) unloading or loading of furniture from a house or office (Order (ii) only);
- (d) delivery or collection of postal packets;
- (e) the maintenance of the roads;
- (f) the supply of gas, water or electricity and of any telegraphic line;
- (g) the pursuance of statutory powers or duties; and
- (h) a funeral cortege.

Copies of the Orders and maps showing the restricted roads (with alternative routes for Order (iii)) may be inspected at my Office during normal office hours (except Saturdays).

If you wish to question the validity of the Orders or of any provision contained in them on the grounds that they are not within the powers conferred by the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, or on the grounds that any requirement of that Act or of any instrument made under it has not been complied

GOSPORT BOROUGH COUNCIL

The Borough of Gosport (South Street) (Prohibition of Waiting) Order 1972
