

by Part IX of the Transport Act 1968, the effect of which will be that no person shall, until the said works are completed or until 24 December 1972, whichever is the earlier, cause any vehicle to proceed in that length of the Newtown—Aberystwyth Trunk Road (A.492) known as Long Bridge Street at Llanidloes in the County of Montgomery, which extends from its junction with the Brook Street/Hafren Street roundabout in a south-westerly direction for a distance of 100 yards. The Order also provides for the one-way traffic system in Bethel Street, imposed by the County of Montgomery (Bethel Street, Llanidloes) (One Way) Order, 1968, to be reversed. That is, while this Order remains in force, no person shall cause or permit any vehicle to proceed in that length of road known as Bethel Street at Llanidloes in the County of Montgomery, which extends from its junction with Great Oak Street to its junction with Brook Street, in a direction other than from south-west to north-east.

The alternative routes which will be available are as follows:

For west bound traffic: from the roundabout at the Long Bridge Street/Brook Street/Hafren Street junction along Brook Street, Foundary Terrace, Cambrian Place, High Street and New Street to join the trunk road at the southern end of Smithfield Street.

For east bound traffic: from the southern point of Smithfield Street along New Street, High Street, Great Oak Street, Bethel Street, and Brook Street to join the trunk road at the roundabout at the Long Bridge Street/Hafren Street/Brook Street junction.
