This Order consolidates the list of drugs and medicines which were free of purchase tax at the date of the making of this Order. The list supersedes the existing list shown in the Purchase Tax (No. 5) Order, 1971, and includes items subsequently exempted from tax by directions of the Commissioners of Customs and Excise under section 17 (3) of the Purchase Tax Act, 1963.

The Order does not exempt any additional substance or cancel any existing exemption, but some chemical descriptions have been revised and some items previously listed under their chemical names now appear under-named approved by the British Pharmacopocia Commission.

The Order comes into operation on 9th December 1972 and has been published as Statutory Instruments 1972, No. 1745.
