The following is a draft of an Order proposed to be made by the Secretary of State for the Environment.

**ANCIENT MONUMENTS ACTS 1913 TO 1953
PRESERVATION ORDER**

Made - - - - - 197
Coming into Operation 197

The Secretary of State for the Environment, in exercise of the powers conferred upon him by section 11 of the Historic Buildings and Ancient Monuments Act 1953 and of all other powers enabling him in this behalf, hereby makes the following Order:

1. In this Order:

- (a) "the Act" means the Historic Buildings and Ancient Monuments Act 1953;
- (b) "the Secretary of State" means the Secretary of State for the Environment;
- (c) "the monument" means the ancient monument known as Witley Court in the Parish of Great Witley in the County of Worcester shown on the plan annexed to this Order and thereon coloured pink;

2. The monument (in respect of which an Interim Preservation Notice served under section 10 of the Act and a Guardianship Order under section 12 (5) of the Act are in force) is hereby placed under the more lasting protection of the Secretary of State.

3. Any question as to a person's right to compensation under sections 12 (2) and 12 (6) of the Act, or as to the amount of any such compensation which is appropriate in the circumstances, shall, as respects this Order, as respects the Interim Preservation Notice superseded by this Order, and as respects the Guardianship Order, in default of agreement be determined by the Lands Tribunal.

4. This Order may be cited as the Witley Court Preservation Order 197 .

Notice is hereby given in pursuance of section 85 (3) of the Diseases of Animals Act 1950 that the Minister of Agriculture, Fisheries and Food and the Secretary

of State for Scotland, acting jointly, have made the following Order:

**STATUTORY INSTRUMENTS 1972 No. 1644
*The Importation of Canadian Cattle (Amendment)
Order 1972*
(Made 31st October 1972)**

This Order which comes into operation on the 1st December 1972, revokes and re-enacts with amendments the Importation of Canadian Cattle (Amendment Order 1963. Blue tongue is added to the diseases of animals declared to be diseases within the meaning of section 29 (2) (c) (ii) of the Diseases of Animals Act 1950 and it becomes a condition of landing Canadian cattle in Great Britain without slaughter that the Minister and the Secretary of State must be satisfied that the cattle were not at the time of shipment affected with these diseases. Additional requirements are also imposed as to the terms of the certificates required before cattle can be landed and certain of the existing terms are modified.
