#### WASHINGTON DEVELOPMENT CORPORATION

(New Towns Act 1965, section 7; Compulsory Purchase Act 1965 as applied by the New Towns Act 1965)

*The Washington Development Corporation Compulsory Purchase Order (Pattinson North) No. 5 of 1972*

Notice is hereby given that the Washington Development Corporation in pursuance of their powers under section 7 of the New Towns Act 1965, on 17th November 1972, made an Order which has been submitted for confirmation by the Secretary of State for the Environment authorising them to purchase compulsorily for the purpose of highway, industrial, open space and other New Town development the lands described in the Schedule hereto.

A copy of the Order, and of the map referred to therein, have been deposited at Usworth Hall, Washington, and will be open for inspection without payment of fee during normal office hours.

Any objection to the Order must be made in writing, stating the grounds of the objection, and addressed to the Secretary of State for the Environment, Caxton House, Tothill Street, London, SW1H 9LZ before 28th December 1972.

The Minister is not, in all cases, required to arrange for objections to be heard by a person appointed by him for that purpose. It is important, therefore, that an objection should include a full statement in writing of the grounds on which the objection is made as the objector may have no further opportunity to make such a statement.
