The London Borough of Bromley (Footpath Number 41 Upper Ruxley) (Part) Public Path Diversion Order, 1972.

Notice is hereby given that the above-named Order, made on 1st December 1972, is about to be submitted to the Secretary of State for the Environment for confirmation, or to be confirmed, as an unopposed Order by the Council of the London Borough of Bromley.

The effect of the Order, if confirmed without modifications, will be to divert the public right of way (No. 41) at Upper Ruxley, Maidstone Road, in the London Borough of Bromley running in an easterly direction for approximately 113 yards from the south-western corner of the allotment garden (O.S. Field No. 5182) and then in a northerly direction for approximately 130 yards to a point approximately 42 yards south of the carriageway of Maidstone Road to a line running from the said south-western corner of the allotment garden for approximately 185 yards in a northerly direction and then in a south-easterly direction for approximately 90 yards (adjacent to the southern boundary of the accessway at the rear of Sunnyside Cottages) to rejoin the existing footpath.
