Notice is hereby given that the Greater London Council on 30th November 1972, made the above-mentioned Order under sections 6 and 84D of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968.

The general effect of the Order will be to create an urban clearway in that length of London Road (A.21) in the London Borough of Bromley which lies north-west of a point 64 feet north-west of the north-western kerb-line of Hope Park. Thus, except with the permission or at the direction of a police constable in uniform:

- (a) waiting by vehicles (otherwise than for the purpose of delivering or collecting goods or loading or unloading a vehicle) during the time between 8 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive will be prohibited in the length of street specified in Schedule 1 to this notice and in the first 60 feet of adjacent lengths of the streets specified in Schedule 2 to this notice;
- (b) waiting by vehicles for the purpose of delivering or collecting goods or loading or unloading a vehicle will be prohibited—

 (i) during the time between 8 a.m. and 9.30 a.m. and 4.30 p.m. and 6.30 p.m. on Mondays to Fridays inclusive in the length of street specified in Schedule 3 to this notice;

(b) at an authorised stopping place or at a turning or terminal point if such vehicles are being used

to provide a London bus service or under a road service licence;
(c) in certain circumstances, for the taking in of petrol, oil, water or air;
(d) for the purpose of collecting or delivering certain
