The Lords Commissioners of Her Majesty's Treasury hereby give notice that they have made an Order under sections 3 (6) and 13 of the Import Duties Act 1958.

Viz: THE IMPORT DUTIES (TEMPORARY EXEMPTIONS) (No. 1) ORDER 1973.

This Order provides that the goods listed in the Schedule shall be exempt, or continue to be exempt, from import duty until 1st January 1974, or until such earlier date as is specified in the Schedule. (The exemption is continued in the case of herring and other fish oils, which now fall within sub-heading 15.04 (C) of the Customs Tariff 1959.)

The Order comes into operation on 1st February 1973 and has been published as Statutory Instruments 1973 No. 41.

The Trunk Road (Long Bridge Street, Llanidloes)
(Temporary Prohibition of Traffic) Order 1973

Notice is hereby given that to enable works to be carried out, the Secretary of State for Wales intends to make an Order under section 12 (1), (4) and (5) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which will be that no person shall, from 22nd January 1973, until the said works are completed or until 17th February 1973, whichever is the earlier cause any vehicle to proceed in that length of the Newtown—Aberystwyth Trunk Road (A492) known as Long Bridge Street at Llanidloes in the County of Montgomery, which extends from its junction with the Brook Street/Hafren Street roundabout in a south-westerly direction for a distance of 100 yards. The Order also provides for the one-way traffic system in Bethel Street, imposed by the County of Montgomery (Bethel Street, Llanidloes) (One Way) Order 1968, to be reversed. That is, while
