intervals as the Secretary of State for Defence may determine.

- 3. The declaration shall state:
- (a) that the declarant is entitled to receive the payment ;
- (b) the full name of the pensioner;
- (c) the service in respect of which the pension was awarded.

4. The declaration is to be completed and signed by the person entitled to receive payment of the pension in the presence of a witness, who must be a person other than the pensioner or the wife or husband of the pensioner or of the declarant, who holds one of the following qualifica-tions or such qualification as the Secretary of State for Defence may decide:

- (1) Where the declaration is made in the United Kingdom, the Channel Islands or the Isle of Man
 - (a) a person registered in the United Kingdom as a Parliamentary elector or on the electoral roll of Jersey, Guernsey or Sark, or the register of electors of Alderney or the Isle of Man;
- (2) Where a declaration is made outside the United Kingdom, the Channel Islands or Isle of Man
 - (a) a person registered in the United Kingdom as a Parliamentary elector.
 - (b) an officer on the active or half-pay or pension list of any of Her Majesty's Armed Forces;
 - (c) a person who is on the active or pension list of the permanent civil service of any territory within the British Commonwealth or the Republic of Ireland ;
 - (d) a member of Her Majesty's Diplomatic Service;
 - (e) an officer of a bank authorised to sign documents on its behalf;
 - (f) a physician or surgeon registered as such under the laws of the territory where the declaration is made :

 - (*b*) a master of religion ; (*b*) a master of a merchant ship being a British subect :
 - (i) a graduate of a university in the British Com-monwealth or the Republic of Ireland;

 - (i) a magistrate; (k) a barrister, solicitor or advocate authorised to practise in the territory where the declaration is made ;
 - (1) a notary public or other person competent by the law of the territory where the declaration is made to administer oaths;
 - (m) in the Channel Islands or the Isle of Man an elector on a local roll or register of electors.

5. The person before whom the declaration is made shall state:

- (a) the full qualifications which entitle him to attest;
- (b) that the declaration was made in his presence;
- (c) that he believes the person making the declaration to be the person entitled to payment.

6. Where the declaration is made by a person on behalf of the pensioner it shall be supported by a statement made by a person having the required qualifications prescribed in Clause 4, or such other qualifications as the Secretary of State for Defence may decide, and not being the wife or husband of the pensioner or declarant, stating when he last saw the pensioner alive.

7. It shall not be necessary for a declaration to be made if payment of a pension is made in accordance with the provisions of Part IX Section 138 of the Mental Health Act 1959 c.72 (which relates to the payment of pensions to persons who are unable by reason of mental disorder to manage their own affairs).
