*The Hampshire (Kingsclere and Whitchurch Rural District No. 28) (Parish of Baughurst—Part of Footpaths Nos. 24 and 25) Public Path Diversion Order, 1972.*

Notice is hereby given that on the 20th December 1972, the Hampshire County Council confirmed the above-named Order.

The effect of the Order as confirmed is to divert the public rights of way in the parish of Baughurst described in Part I of the Schedule hereto to the route described in the Second Part.

Copies of the confirmed Order and map contained in it have been deposited at the office of the Clerk of the Kingsclere and Whitchurch Rural District Council, Council Offices, Kingsclere, Newbury, Berkshire, and at the office of the undersigned, where they may be inspected free of charge during normal office hours.

The Order becomes operative as from 15th February 1973, but if any person aggrieved by the Order desires to question the validity thereof or of any provision contained therein on the grounds that it is not within the powers of the Highways Act, 1959, as amended, or on the ground that any requirement of the Act, or any regulation made thereunder has not been complied with in relation to the confirmation of the Order, he may under paragraph 2 of Schedule 2 to the Act as applied by paragraph 5 of Schedule 7 to the Act, within six weeks from 15th February 1973, make application for the purpose to the High Court.

#### SCHEDULE

##### PART I

##### *Description of Site of Existing Paths*

Those parts of the footpaths in the parish of Baughurst in the rural district of Kingsclere and Whitchurch shown on the Definitive Map of Public Rights of Way under Part IV of the National Parks and Access to the Countryside Act, 1949, as:

- (1) Footpath No. 24 running from Road C.101 south-eastwards through Stratton Manor gate, then southwards for a distance of 594 yards.
- (2) Footpath No. 25 running south-eastwards from Footpath No. 24 for a distance of 109 yards.

##### PART II

##### *Description of Site of Alternative Paths*

(a) A footpath running from Road C.101, approximately 50 yards north-west of the entrance to Stratton Manor, over a culvert and stile, southwards along a 4 foot wide unenclosed grass path for a distance of 197 yards, over a stile and southwards along a 4 foot unenclosed grass path for a distance of 263 yards, then over two stiles and south-eastwards along a 4 foot grass path on the north-east side of a fence for a distance of 124 yards to a stile, and joining Footpath No. 24 at the southern end of the length described at (1) in Part I of this Schedule.

(b) A footpath running from a stile on the existing Footpath No. 25 at the southern end of the length described at (2) in Part I of this Schedule, north-west along a 4 foot wide unenclosed grass path to a stile and meeting the existing Footpath No. 24 at the same point as the length of path described at (a) above (a distance of 100 yards).
