Notice is hereby given that on the 27th February 1973, the County Council of the West Riding of Yorkshire made Orders under the Road Traffic Regulation Act, 1967, as amended by Part IX of the Transport Act, 1968, which will have the following effective have the following effect:

1. The County of the West Riding of Yorkshire (Wade House Road and Shelf Hall Lane, Shelf) (Prohibition of Waiting) Order, 1973:

(a) To prohibit waiting by vehicles at all times on the following lengths of sides of road at Shelf in the Queensbury and Shelf Urban District:

- Wade House Road (A.6036), north-western side from its junction with Shelf Hall Lane (District Road) for a distance of 16 yards in a south-westerly direction.
- Shelf Hall Lane (District Road), south-eastern side from its junction with Wade House Avenue for a distance of 65 yards in a south-westerly direction.
- Shelf Hall Lane (District Road), north-western side from its junction with Wade House Avenue for a distance of 20 yards in a south-westerly direction.

(b) To prohibit waiting by vehicles between 8 a.m. and 6 p.m. Mondays to Fridays on the north-western side of Shelf Hall Lane (District Road) at Shelf, which extends from a point 20 yards south-west of its junction with Wade

House Avenue for a distance of 45 yards in a south-westerly direction.

2. The County of the West Riding of Yorkshire (Calder Street and Bridge Street, Todmorden) (Prohibition of Waiting and One-Way) Order, 1973:

(a) To prohibit waiting by vehicles on the following length of road, sides of road or length of side of road in the Borough of Todmorden:

- School Lane (District Road), both sides from its junction with Bridge Street for a distance of 5 yards in an easterly direction.
- Calder Street (District Road)

Northern side.

Southern side, from the junction with Bridge Street for a distance of 5 yards in an easterly direction.

Bridge Street (District Road), eastern side.

(b) To prohibit any vehicle from proceeding in the roads in the Borough of Todmorden specified in Column 1 below in a direction other than that specified in Column 2 below:

3. The County of the West Riding of Yorkshire (Durkar Low Lane, Durkar) (Prohibition of Right Hand Turn) (Experimental) Order, 1973:

To prevent any vehicles proceeding on the Durkar-Walton-Crofton-Sharlston (Class II) County Road (B.6378) (Durkar Low Lane) at Durkar, from making a right hand turn into the Denby Dale and Wakefield (Class I) County Road in the Wakefield Rural District.

The Order will continue in force for a period of six months.

4. The County of the West Riding of Yorkshire (Hudders-field Road, Mirfield) (Prohibition of Waiting) Order, 1973 :

To prohibit waiting by vehicles on that length of the northern side of Huddersfield Road (A.644) at Mirfield which extends from a point 24 yards west of King Street to a point 17 yards east of St. Paul's Road.

5. The County of the West Riding of Yorkshire (Hudders-field Road, New Mill) (Prohibition of Waiting) Order, 1973.

To prohibit waiting by vehicles on that length of Huddersfield Road (western side) at New Mill in the Holmfirth Urban District which extends from a point 78 yards south of the northerly side of its junction with Cold Hill Lane to a point 7 yards north of the northerly side of that junction.

6. The County of the West Riding of Yorkshire (Grains Bar and Delph County Road, Delph) (Weight Restruction) Order, 1973:

When this Order comes into effect no vehicle the weight of which (whether laden or unladen) exceeds 3 tons, will be allowed to proceed in that length of the Grains Bar and Delph (Class II) County Road which extends from its junc-tion with the Oldham and Ripponden (Class I) County Road at Grains Bar to its junction with the Denshaw and Debcross (Class I) County Road at Delph in the Saddleworth Urban District.

7. The County of the West Riding of Yorkshire (Various Roads at Rossington) (Restriction of Waiting) Order, 1973 :

To prohibit waiting by vehicles between 10 a.m. and 8 p.m. Mondays to Saturdays in the following roads at Ross-ington in the Doncaster Rural District:

Gattison Lane

North-western side, from the junction with Mayfield Crescent to the junction with Aberconway Crescent.

South-eastern side, from a point 45 feet north-east of the junction with Clay Flat Lane to the junction with Aberconway Crescent (excluding the lay-by in front of the supermarket).

Clay Flat Lane, from the junction with Gattison Lane for a distance of 80 feet in an easterly direction. Oakdene, from the junction with Gattison Lane to the

junction with Hazel Grove.
