BRIGHTON COUNTY BOROUGH COUNCIL

The Brighton Corporation (Restriction of Waiting and Loading No. 1 Order 1969 Consolidation Order 1972) (Amendment No. 1) Order, 1973.

Notice is hereby given that on the 8th March 1973 the Brighton County Borough Council made an Order under sections 1 (1), (2) and (3) and section 84D (1) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which is to amend the Brighton Corporation (Restriction of Waiting and Loading No. 1 Order 1969) (Consolidation) Order 1972 so as to prohibit waiting at all times on the west side of the western carriageway of Regency Square from King's Road, northwards for 88 feet.
