CORNWALL COUNTY COUNCIL

The County of Cornwall (Looe) (Various Streets) (Prohibition of Waiting) (Amendment) Order, 1973

Notice is hereby given that the Cornwall County Council propose to make an Order under sections 1 and 84D of the Road Traffic Regulation Act, 1967, as amended by Part IX of the Transport Act, 1968, the effect of which will be:

- (a) to prohibit the waiting of vehicles
 - (i) between the hours of 9 a.m. and 10 p.m. daily from the 1st May to 30th September (both dates inclusive) in each year in that length of the Looe-Sandplace Road (A.387) which extends from a point 38 yards north of its junction with Shutta for a distance of 500 yards in a northerly direction;
 - (ii) between the hours of 10 a.m. and 10 p.m. daily from the 1st May to 30th September (both dates inclusive) in each year in—
 - (A) Downs Road (unclassified)—from a point 15 yards east of its junction with West Road for a distance of 162 yards in an easterly direction;
 - (B) Polvellan Terrace (unclassified)—between its junctions with West Road and the Looe-Polperro Road (A.387); and
- (b) to amend existing traffic regulation Orders in operation in the Urban District of Looe as may be necessary to give effect to the foregoing.

Exceptions will be provided in the Order to allow a vehicle to wait for so long as may be necessary to allow a person to board or alight from the vehicle; to enable goods to be loaded or unloaded; in connection with statutory powers or duties, building operations, the maintenance or improvement of the lengths of road or of the services therein; to take in petrol, oil, water or air from a garage and in connection with a funeral.
