**DERBYSHIRE COUNTY COUNCIL**

*The Derbyshire County Council (Heath Village) (Chesterfield Rural District) (Weight Restriction) Order 1973*

Notice is hereby given that on the 8th March 1973 the Derbyshire County Council made an Order under section 1 of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968.

The effect of this Order is to prohibit any vehicle, the weight of which (whether laden or unladen) exceeds three tons, from proceeding in the length of County classified road through Heath Village, which extends from its junction with Sutton Lane in an easterly then southerly and south-westerly direction to its junction with the A.6175 (between Slack Lane and Mill Lane). The usual exemptions have been included so as to permit a vehicle to be used for the conveyance of persons, goods or merchandise to or from any premises situated on or adjacent to the roads and having access therefrom or to gain access to such premises.

The Order will come into operation on the 1st April 1973.

A copy of the Order together with a map showing the restricted length of road may be examined at the County Offices, Matlock (Room 109) between the hours of 9 a.m. and 5 p.m., Monday to Friday.

If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968 or on the grounds that any requirement of that Act or of any instrument made under it, has not been complied with in relation to the Order, you may within 6 weeks from the 8th March 1973 apply to the High Court for this purpose.
