The Urban District of Farnham (General Traffic Control) Order 1968 (Amendment No. 8) Order 1973

Notice is hereby given that the Farnham Urban District Council propose to make an Order under sections 1 and 28 jointly and 84D of the Road Traffic Regulation Act, 1967 as amended by Part IX of the Transport Act, 1968, the effect of which will be to further amend the Urban District of Farnham (General Traffic Control) Order 1968 so as to provide:

- (a) That no vehicle shall be permitted to wait from 8 a.m. to 6 p.m. on Mondays to Saturdays on the north-east side of Potters Gate from the south-east side of the footpath leading to The Hart north-westwards for a distance of 75 feet.

GLOUCESTERSHIRE COUNTY COUNCIL

The Gloucestershire County Council (Hanham Abbots) (Prohibition of Waiting) Order 1973
