The Order amends The Lowestoft (General) (Prohibition and Restriction of Waiting) (Amendment) (No. 2) Order 1972 made on 21st December 1972.

Fractions are provided in the Order covering persons

Exceptions are provided in the Order covering persons boarding or alighting from vehicles, the delivery and collection of goods, the loading and unloading of vehicles, building operations, road maintenance and repairs or other similar works, the taking in of petrol, oil, water or air from any garage, and for hackney carriages waiting upon authorised stands.

Notice is hereby given that on 5th March 1973 the Manchester City Council made Orders under section 9 of the Road Traffic Regulation Act 1967, as amended, in connection with a scheme for re-organising traffic movements and reducing traffic flows in the St. Ann's Square-King Street area.

The Orders which come into operation on 2nd April 1973 and the effect of them are:

1. City of Manchester (Various Roads) (Experimental One-Way Traffic) Order 1972.

Imposing one-way traffic on the following lengths of road:

Police Street from St. Ann Street to King Street.

Ridgefield from King Street to John Dalton Street. St. Ann Street from St. Ann's Square to Cross Street.

St. Ann Street from St. Ann's Square to Barton Square.

St. Mary's Street from Deansgate to Southgate.

Southgate from St. Mary's Street to Back South Parade.

The existing imposition of one-way traffic on Police Street and St. Mary's Street will be suspended and the one-way traffic flows on those streets will be reversed.

2. City of Manchester (Various Roads) (Experimental Prohibition of Driving) Order (No. 2) 1972.

Prohibiting vehicles from proceeding in the following

lengths of road:

Barton Square.

Bow Street.

Exchange Street.

King Street between Deansgate and Cross Street.

Police Street.

Ridgefield between King Street and John Dalton Street.

St. Ann Street.

St. Ann's Square.

South King Street between Deansgate and St. James's Square.

There are exceptions for the conveyance of persons, goods or merchandise to or from premises on or adjacent to any of the lengths of road or for the purposes of building operations or work on or under any of the lengths of road.

(It is proposed to delete the parking places in the lengths of road by varying the Parking Places and Controlled Parking Zone (Manchester) Order 1971.)
