at Doldowlod in the County of Radnor shall become a trunk road as from the date when the Order comes into operation.

(2) an Order under Section 9 authorising him : (a) to improve, raise, lower or otherwise alter Cilgea Road ;

(b) to stop up highways;

(c) to construct a new highway to connect Cilgea Road with the new Trunk Road ;

(d) to stop up private means of access to premises
