WAGES COUNCIL ACT 1959

COFFIN FURNITURE AND CEREMENT-MAKING WAGES COUNCIL (GREAT BRITAIN)

The Coffin Furniture and Cerement-making Wages Council (Great Britain) hereby gives notice of its intention to submit to the Secretary of State for Employment proposals for (1) increasing the statutory minimum remuneration set out in the Wages Regulation (Coffin Furniture and Cerement-making) Order 1971 (Order U.(80)); (2) amending the provisions relating to holidays and holiday remuneration set out in the Wages Regulation (Coffin Furniture and Cerement-making) (Holidays) Order 1971 (Order U.(81)); and (3) the revocation of Order U.(80).

Particulars of the proposals are contained in the Wages Council's Notice U.(82) which may be obtained on application to the Secretary of the Wages Council at the address given below.

The Wages Council will consider any written representation with respect to the above-mentioned proposals if made to it within 14 days from 30th March 1973. Any such representation should bear the writer's address and signature
