No. 9 Llanbethery

The Conservation Area boundary extends in an easterly direction along the southern boundaries of O.S. Field Parcel Nos. 888, 886, 811, 812, then south along the western boundaries of O.S. Field Parcel Nos. 815 and 867. It then proceeds in a westerly direction along the southern boundaries of O.S. Field Parcel Nos. 869, 877, 876, 875, 881, 880a and 890 and north along the western boundaries of O.S. Field Parcel Nos. 890 and 889 to its commencement.

No. 10 Porthkerry

The Conservation Area boundary starts in the south-west corner of O.S. Field Parcel No. 4 and runs in an easterly direction along the southern boundary of this field and also O.S. Field Parcel No. 3. Then it turns south and then east along the northern boundary of O.S. Field Parcel No. 31, and then in a northerly direction to include part of O.S. Field Parcel Nos. 32 and 37. Then skirting and including O.S. Field Parcel No. 25 back to its commencement.

No. 11 Wenwoc

The Conservation Area boundary starts at the junction of Old Port Road and Port Road (A.4050) and proceeds in a northerly direction following the rear boundaries of the properties fronting onto Old Port Road as far as Station Road. It then runs in a westerly direction along the southern boundary of Station Road, to the north of Wenwoc Church in Wales School, and the southern edge of Wenwoc Close and the eastern side of Wallston Road as far as No. 9 Wallston Road, then along the southern boundary of this property as far as "The Homestead". Then it runs in a southerly direction on the east boundary of "The Homestead" and along the western boundaries of the properties in Rectory Close. Then in an easterly direction along the southern boundary of No. 2 Port Road and north along the eastern boundary of this property as far as the Old Port Road and Port Road junction.

No. 12 Rhoose

The Conservation Area boundary extends from the north-west corner of the Nursery in a southerly direction along the western boundary of the Nursery and crosses the B.4265 road, then in an easterly direction between the B.4265 and Church Road and along the northern boundary of O.S. Field Parcel No. 95 and then north along the western boundary of O.S. Field Parcel No. 78, crossing the B.4265 and skirting to include "St. Arthurs" and along the eastern boundary of O.S. Field Parcel No. 536. Then turning in a westerly direction along the northern boundaries of O.S. Field Parcel Nos. 536 and 565 back to its commencement.

No. 13 East Aberthaw

The Conservation Area boundary extends from the B.4265 road eastwards along the northern boundary of O.S. Field Parcel No. 406 turns south and follows the western boundary of this field and fields 434 and 433. Then extends westwards along the southern boundaries of O.S. Field Parcel Nos. 433 and 437, and crosses the B.4265 road and railway as far as the centre of the rail bed. It then follows the track northwards to the junction with the northern boundary of O.S. Field Parcel No. 441, along which it proceeds in an easterly direction, crossing the road to its commencement.

Documents including a map showing the precise boundaries of the designated areas have been deposited at the offices of the County Planning Officer, County Council Offices, Greyfriars Road, Cardiff, and in respect of area No. 1 at the offices of the Clerk to Penybont Rural District Council, Council Offices, Coity Road, Bridgend, and for areas Nos. 2 to 13 at the offices of the Engineer and Surveyor, Cardiff Rural District Council, Council Offices, 20 Park Place, Cardiff, and may be inspected by the public at all reasonable hours.

The Huntingdon and Peterborough (Helpston Footpath Number 5) Stopping-Up and Diversion Order Number 3, 1973.

Notice is hereby given that the above-named Order hereinafter referred to as the Order made on 27th March 1973, is about to be submitted to the Secretary for the Department of the Environment for confirmation or to be confirmed by the Huntingdon and Peterborough County Council as an unopposed Order. The effect of the Order if confirmed without modification will be to stop-up a length of 80 metres of footpath Number 5 for the Parish of Helpston running in a southerly direction from West Street, Helpston to where it meets footpath Number 4 for the Parish of Helpston and to provide an alternative footpath running from West Street in a southerly direction for 83 metres to meet footpath Number 4 for the Parish of Helpston.

A copy of the Order and map contained in it has been deposited at the offices of the Huntingdon and Peterborough County Council, County Buildings, Huntingdon and the offices of the Peterborough Rural District Council at 55 Priestgate, Peterborough and may be inspected there free of charge on weekdays except Saturday between the hours of 9 a.m. and 4 p.m.

Any representation or objection with respect to the Order may be sent in writing to the Clerk of the Huntingdon and Peterborough County Council, County Buildings, Huntingdon not later than 29 days after the first publication of this notice.

If no representation or objections are duly made or if any so made are withdrawn the Huntingdon and Peterborough County Council may instead of submitting the Order to the Secretary for the Department of the Environment themselves confirm the Order as an unopposed Order.

If the Order is submitted to the Secretary for confirmation any representations or objections which have been duly made and not withdrawn will be sent to the Secretary with the Order.

Notice is hereby given that the above-mentioned Direction has been made by the County Council of Lincoln, Parts of Lindsey in pursuance of the powers conferred in Article 4 of the Town and Country Planning General Development Order 1963 and has been approved by the Secretary of State for the Environment.
