TOWN AND COUNTRY PLANNING ACT 1971

The Secretary of State for the Environment hereby gives notice that he proposes to make an Order under sections 212 and 287 (3) of the above Act to vary the conversion of highways into footpaths or bridleways (City and County Borough of Stoke-on-Trent) (No. 2) Order 1972, by altering in Schedule 1 thereto and on the deposited plan the name of the highway converted into footpath from Joseph Street to Saint Joseph Street.

During 28 days from the 10th April 1973 copies of both Orders may be inspected at the Town Hall, Stoke-on-Trent and may be obtained free of charge from the Secretary of State (quoting TTP 44/200/02), at the address stated below.
