

the line bounding the southern-most bank of the Nadder to include the Palladian Bridge and the Bull Bridge on South Street. The western line encompasses those buildings fronting South Street and West Street, partly following the course of the Nadder to the rear of those properties, the western limit being St. John's Square and those buildings enclosing it including St. John's Hospital and Almshouses. The northern line follows the Wylde and encompasses all those buildings fronting the north side of West Street and all the buildings fronting North Street to the junction of North Street with the Warminster Road (A.36). The line then bounds the Warminster Road to include the Carpet Factory, Recreation Ground, the eastern limit being St. Peter's Church. The eastern line then crosses the Wylde to include the mature trees and wall forming the approach to Wilton House and then follows the river Wylde to its junction with the Nadder.

The Conservation Area

Coombe Bissett: It encompasses the majority of the village, the southern line bounds the rear of properties fronting the Coombe Bissett-Homington Road at varying depths, the eastern limit being the Baptist Chapel and its immediate environs. The north-eastern boundary is formed by the River Ebbel and the rear of properties bounding the eastern side of the A.354. To the north the line bounds properties and land fronting the A.354 at varying depths, stopping short of the sewage disposal works. The western line incorporates land adjacent to Manor Farm and Jervoise's Farm, and terminates at St. Michael's Church and Church Farm to the south.

The eastern line bounds in varying depths those properties fronting Church Street, Noble Street and Tanners Hill. The north boundary is formed by Green Lane and includes the properties and land opposite the Carpenters Arms, up to and including the Police Station.

Designation of Conservation Areas at: Aldbourne and Ramsbury

Notice is hereby given that the Wiltshire County Council as Local Planning Authority, in pursuance of the powers conferred upon them by section 277 of the Town and Country Planning Act 1971, have designated the areas specified in the Schedule hereto within Marlborough & Ramsbury Rural District as Conservation Areas being areas of special architectural or historic interest, the character or appearance of which it is desirable to preserve or enhance.

Plans showing the boundaries of the Conservation Areas are available for inspection during normal office hours at the Clerk's Office (Room 220), County Hall, Trowbridge, and at the offices of the Clerk of the Marlborough & Ramsbury Rural District Council, London Road, Marlborough.

SCHEDULE

The Conservation Areas

Aldbourne: Encompasses the majority of the older part of the village, the northern limit being formed by a boundary adjacent to Old Court House and Woodleys Cottage and Barn, to include the belt of mature trees to the west. The western line again runs adjacent to Woodleys Cottage and Barn, crossing West Street to include Manor Farm. The southern line includes the mature tree belt adjoining the Aldbourne Ogbourne St. George Road to Castle Street, to exclude the properties fronting Whitley Road and linking with the Marlborough Road to include the majority of The Butts. The remainder of the southern line then runs from The Butts to South Street including the recreation ground. The eastern line excludes Malthouse Farm, but bounds the rear of properties fronting South Street, including the Old Malt House, Yewtree House and Bay House, plus those properties fronting Oxford Street at varying depths. The line crosses the Aldbourne-Baydon Road, north-east of the junction of Oxford Street and Lottage Road, linking through to the properties 7-9 and 11 Lottage Road adjacent to Cherry Corner, continuing to bound the footpath leading to Old Court House.

Ramsbury: Encompasses the whole of the Village from the western end of the Village with the junction of High Street and Back Lane, to include all buildings around the junction. The southern line bounds the High Street and Scholars Lane at varying depths. The eastern limit here includes The Old Mill, the line crossing Scholars Lane bounding the rear of properties fronting Union Street, crossing Oxford Street and bounding the rear of properties fronting Crowood Lane. The line stops short of the bend to the north of Crowood Lane, so as to exclude the open space and properties adjacent to the junction with Swan's Bottom. The line then bounds the northern side of Oxford Street (excluding the Council development) and Back Lane to varying depths.
