## The Conservation Areas

Chilmark: Encompasses the majority of the village, the northern boundary being formed by the B.3089 including the Black Dog Inn and its immediate environs. The western line bounds the road linking the B.3089 with The Street, to include Chilmark House and the avenue of trees to the west of the crossroads. The line continues to bound the rear of properties fronting The Street and either side of Beckett's Lane, at varying depths to a point 100 yards south of the junction with Frog Lane, but excluding all dwellings of a more recent origin adjacent to Frog Lane and Beckett's Lane. The eastern boundary links the B.3089 with The Street, to include the Bridge Inn Stores, the School and Rectory with their immediate environs.

Mere: Encompasses the majority of the town, including the Castle and Long Hill and immediate environs to the north of Castle Street. The southern line includes St. Michael's Church, Chantry House and The Church Street area, bounding the southern side of Salisbury Street at varying depths, to include the old Carpet Factory and properties fronting the eastern side of Water Street. The line containing the eastern end of the town includes the Milk Factory and the Old Hollow and Well Head areas. The area north of North Street, between Well Head and the Castle, is excluded from the Conservation Area.

The Teffonts: It encompasses the majority of both villages. In Teffont Magna the line bounds the rear of properties and land either side of the Class C village road, at varying depths, north of the junction with the B.3089, to include St. Edward's Church and Manor Farm with

In Teffont Magna the line bounds the rear of properties and land either side of the Class C village road, at varying depths, north of the junction with the B.3089, to include St. Edward's Church and Manor Farm with their immediate environs. The northern boundary terminates on the road bend north of Manor Farm. The line continues to bound properties and land fronting the B.3089 at varying depths through Teffont Magna as far as the Black Horse Public House. In Teffont Evias the northeastern boundary is formed by the B.3089 terminating at the Lodge, the south-eastern boundary by the Class C road as far as the old quarry. The western line bounds the rear of properties and land at varying depths adjacent to the village C class road.

The northern limit is formed by the now somewhat overgrown northern branch of the River Wylye and encompasses the converted old Corn Mill and its immediate environs. The western line then proceeds south across the Wylye, west of the Castle Mound and the "Manor Farm", to the main road and "The Old Farnhouse".

Stockton: It encompasses the whole of the village, commencing at (and including) Glebe Farm and the Rectory to the east. ## The Conservation Areas

Biddestone: Includes the whole of the village, from Biddestone Manor and land to the far south-east together with the field and wall to the west of the approach road from Corsham. The southern line then bounds the village in varying depths from the green, including the White Hart Public House, Pool Farm, the school, rectory, Mountjoy Farm, to the western limit—Lynch Gate.

The western limit includes the Butts and cottage adjoin-

The western limit includes the Butts and cottage adjoining Westbury, continuing north to include the land containing St. Nicholas's Church, Church Row and Church Cottages, and running parallel, to a depth of approximately 300 feet, with Cuttle Lane.

The northern limit is the road junction to Slaughterford and contains the isolated group of buildings and trees, including the Post Office, the Malthouse and adjoining cottages and Nos. 1, 2 and 3 Slaughterford Road. The line cuts the Yatton Keynell road 350 feet north of the sports field pavilion. The eastern limit includes the sports field and land to an approximate depth of 450 feet from Cuttle Lane and again bounds the village in varying depths from the green adjoining the public footpath to Home Farm. The line then follows the boundaries to Manor Farm and Biddestone Manor.

Kingston Langley: Includes the Great House, Langley Gate Farm plus outbuildings, all groups of cottages and
